

CURRICULUM VITAE – ASSOCIATE PROFESSOR SULETTE LOMBARD

Sulette commenced her career in academia in 1997 and over the last twenty plus years had the opportunity to teach into an array of commercial law subjects, primarily corporate law and insolvency law, at an undergraduate and post-graduate level, both in Australia and South Africa. She supervised a number of honours students as well as post-graduate students and research in areas that are linked to her teaching.

She has authored and co-authored books, book chapters, a number of articles in high quality, peer-reviewed law journals, as well as presented at local and international conferences. She is a member of the Australian Law Council’s Corporations Committee, as well as the Australian Law Council’s Insolvency and Restructuring Committee.

She actively engages with the legal community by way of membership of professional bodies, and participation in law reform processes, most recently by way of Submission to the Parliament of Australia in relation to ‘Litigation funding and the regulation of the class action industry’ (with Prof Christopher Symes). Sulette appeared as an expert witness before Parliament on the basis of the Submission and along with Prof Christopher Symes, were subsequently cited extensively in the Report (December 2020).

Sulette has previous experience in leading a research team that included academics and practitioners from Australia, Canada and the USA. This project culminated in the publication of a book of edited contributions in 2020 with Springer Nature Singapore Pte Ltd.
