## **CURRICULUM VITAE – Prof Andre Boraine**

Prof André Boraine is the former Dean of the Faculty of Law, UP and a former Deputy Dean and former Head of the Department of Procedural Law, UP. His second term as dean of the Faculty of Law expired on 31 October 2019. During his second term as Dean, the UP Law Faculty soared to position 76 on the THE world ranking for law faculties in 2019 and is currently the highest ranking law faculty in Africa. He also established the Centre for Advanced Corporate and Insolvency Law (now CILC) based in the Faculty of Law and served as its first Co-director.

His research interests include insolvency law, with a particular focus on international insolvency; the law of civil procedure; and aspects of property and consumer law. He publishes widely in national and international peer-reviewed journals and has contributed to a number of local and foreign texts. He is currently the co-author of the primary text on Insolvency law in South Africa, namely *Meskin Insolvency Law* and the chapter on South African insolvency and rescue law in *Collier International Business Insolvency Guide*. He was also a co-author of the 3<sup>rd</sup> ed of *Silberberg and Schoeman: Property law*.

He serves on the editorial panel of the *International Insolvency Law Review* and he serves on editorial advisory board of the *Nottingham Insolvency and Business Law*. He has acted as referee for numerous publications in national and international journals, as well as applications for NRF ratings. He served on the Management Board of the Academic Forum of INSOL International and is an honorary member of the South African Rescue and Insolvency Practitioners Association of South Africa.

He was recognised twice as an Exceptional Achiever by the University of Pretoria and also received the INSOL Fellowship Award and in this respect produced four research papers for INSOL International in 2008. Since 2016, Prof Boraine, on appointment by the Minister of Justice, serves on the advisory committee of the South African Law Reform Commission revising debt relief measures for consumer debtors.

The World Bank appointed him as their consultant on insolvency-related matters regarding an assessment of the legal framework which regulates insolvency law and creditor's and debtor's rights in South Africa, and subsequently, he was also a member of the World Bank team who conducted a similar assessment of Namibian Insolvency law. The assessment results were utilised in the *World Bank Report on the Observance of Standards and Codes for insolvency and debtor's rights (ROSCs)*. He also served as peer reviewer of the World Bank ROSC for Zimbabwe in 2015.

Since 2015 he is a member of the IEEI and as from 2016 he is a member of the prestigious *International Insolvency Institute* on invite and as such he serves as the representative on a III working committee for the African region.

André was recently appointed as the Director of the Unit for Business Rescue and Insolvency Law at UP (Law).
