I am an English, Hong Kong and British Virgin Islands qualified lawyer with 12 years' post-qualification experience. I am based in London, having spent 10 years in Hong Kong at an international firm practicing offshore work, primarily dealing with disputes involving Cayman and BVI entities with operations in Asia. I have a broad contentious insolvency and restructuring and commercial litigation practice focussing on high value fund disputes, valuation disputes and contentious insolvency proceedings. My role involves providing on-going advice and representation, preparing court papers, instructing counsel (internal and external) and expert witnesses to appear on our clients' behalf in court proceedings in the Caribbean and generally project manage litigation proceedings as they proceed to trial.
