# ArcelorMittal USA LLC v Ravi Ruia & ors. [2020] EWHC 3349 (Comm)

This claim concerns long-running litigation between two competitors in the steel and mining industry, and the Claimant's pursuit of an arbitration award. I acted for the Seventh Defendant who, together with the other nine Defendants, resisted certain parts of the Claimant's application to amend its Particulars of Claim which Henshaw J had found did not to set out a good arguable case in a previous Worldwide Freezing Order application. Mr Justice Butcher agreed with the majority of the Defendants' points and awarded costs to the Seventh Defendant on a summary assessment. I remain instructed on this matter.

### Robert Tchenguiz & ors. v Grant Thornton & ors. [2018] (QB)

I acted for the Fifth Defendant. This case concerned allegations made by the property tycoon against the accountancy firm, two of its partners and a former lawyer of Kaupthing Bank (the Fifth Defendant). Mr Tchenguiz accused the Defendants of conspiring to encourage the Serious Fraud Office to launch an investigation into him after the bank's collapse in 2008. Mr Tchenguiz discontinued his claims hours before having to give evidence in the case, and was ordered to pay indemnity costs to the Defendants.

### Chesterfield United Inc (in liquidation) & anor. v Deutsche Bank AG & ors. [2016] (Ch)

I acted for the Claimants. This case concerned EUR 500 million litigation arising from the sale and purchase of credit linked notes (CLNs), including claims under the Financial Services and Markets Act 2000 (FSMA 2000) for market manipulation. Further claims included: unlawful means conspiracy, dishonest assistance and knowing receipt.

### Blue Tropic Ltd & anor. v Ivane Chkhartishvili [2014] EWHC 2243

I acted for the Appellant/Defendant in relation to a jurisdictional challenge concerning EC Regulation 44/2001.

# Rafed Al Khorafi & ors. v Bank Sarasin-Alpen (ME) Limited & anor. (CFI-026-2009)

I acted for the Claimants.
