Adelaide Brighton Cement Ltd v Hallett Concrete Pty Ltd, SA Premium Cement & Concrete Pty Ltd, Mark Stephen Pickard and Barrie Hosking

Acting for Hallett Concrete Pty Ltd, SA Premium Cement & Concrete Pty Ltd and their directors in defending and counterclaiming in proceedings brought in the Supreme Court of South Australia. Matter involves highly complex considerations of contractual construction, validity and enforceability in the context of actual or potential restrictive trade practices contrary to the *Competition and Consumer Act 2010* (Cth), tortious interference with contractual relations and conspiracy to cause loss. Proceedings are ongoing. To date have been instrumental in successfully bringing and defending numerous contested interlocutory arguments, including successfully defending a strike out application, as well as coordinating and undertaking significant discovery of documents.

My role: Working directly with Special Counsel and two Partners to assist in managing a team of 6, taking responsibility for managing segmented work streams.

#### Hamilton v JJR Investment Holdings and Others

Acted for the Justin-EDC/ADC Group, a large property development group, in relation to two applications brought in the Supreme Court of South Australia by one director of the group and members of her immediately family seeking to remove and replace the corporate trustee of certain trusts which hold group assets. Successfully sought and obtained leave for our clients to intervene in the proceedings to oppose the applications, and successfully defended a subsequent disjoinder application. Matter involved issues concerning the rights of beneficiaries in connection with the exercise of the discretion of a trustee of a discretionary trust, the removal of trustees under the *Trustee Act 1936* (SA), breaches of fiduciary duties and breaches of the *Corporations Act 2001* (Cth).

My role: Solicitor with principal conduct of the matter reporting to the responsible Partner, managing a team of 4.

#### FlyCo SA Pty Ltd v Olimarc Pty Ltd

Acted for Olimarc Pty Ltd, a franchisee, in defending proceedings brought in the Magistrates Court of South Australia by the franchisor FlyCo SA Pty Ltd. Matter involved issues relating to the scope and effect of the good faith obligation under the *Franchising Code of Conduct*, contractual construction and implied terms, and conditions subsequent. Successfully negotiated a settlement of the franchisor's claim on terms favourable to the client, and pursued the client's counterclaim through to trial, winning judgment in its favour, including an order for costs. Continued to act for the client in opposing a subsequent appeal brought and argued before the Supreme Court of South Australia, as to which judgment remains reserved.

My role: Solicitor with principal conduct of the matter, limited Partner involvement.

#### Arysta LifeScience Australia Pty Ltd v Patton & Others

Acted for Arysta LifeScience Australia Pty Ltd, a franchisor, in proceedings commenced in the Supreme Court of South Australia against a former franchisee, its director and his associates. Matter involved complex consideration of the enforceability of personal guarantees given in the context of franchise relationships, and breaches of contractual and equitable obligations of good faith and confidence giving rise to breach of contract.

My role: Solicitor with principal conduct of the matter reporting to the responsible Partner, managing a team of 3.

#### Contura Mining Pty Ltd v Jarrad Holdings Pty Ltd

Acted for Contura Mining Pty Ltd, an investor company, in proceedings commenced in the Supreme Court of South Australia against Jarrad Holdings Pty Ltd, seeking to enforce a mortgage security over real property and to secure repayment of debt. Matter included defending a separate proceeding brought in the Supreme Court of South Australia by Jarrad Holdings Pty Ltd against our client, seeking declaratory relief voiding the mortgage ab initio. Matter involved extremely complex consideration of the fiduciary duties on an investor or third party when taking security from a company in significant financial distress, indefeasibility and enforceability of registered mortgages, unconscionability and misleading or deceptive conduct.

#### Sherman v LSH Auto (Sydney) Pty Ltd

Acted for LSH Auto (Sydney) Pty Ltd, a licensed dealer of luxury Mercedes-Benz vehicles, in successfully prosecuting appeal proceedings commenced by it in the New South Wales Civil and Administrative Tribunal. Matter involved complex consideration of the consumer guarantees under the *Australian Consumer Law* and novel arguments on limitations on consumers' rights to reject goods.
