- Calculation of the loss of earnings relating to a claim of PTSD by the client due to the Metropolitan Police publicly reporting on a robbery incident. Subsequently the individual had to take time off work. The calculation related to lost dividends of c£50k and lost income of c£80k.
- Analysis of solicitor firm client bank account due to there being a balance left when the account should net down to nil. Outcome was due to Hackney County Council making duplicate payments.
- Analysis of legitimacy of income of individual who was charged with conspiracy to supply controlled drugs (Class A). The individual stated he was a barber however, the job involved considering his lifestyle and that of a normal barber. The value of criminal property was c£200k and the rest of the job involved tracing cash payments to the defendants several bank accounts.
