- Part of a team mandated with the divestment and monetization of the bank's USD 20bn liquidation portfolio globally. Julius was also tasked with the management and divestment of all equity positions held by the bank's Special Assets group, worldwide.

- Senior role managing the mezzanine fund that UOB jointly sponsored with Orix Corporation. The fund had a Southeast Asian mandate and was seeded with USD 100m capital. Julius was in charge of managing deal flow and executing mezzanine and structured equity opportunities in Indonesia. He held directorship role with the fund's General Partner entity.

- Member of the bank's proprietary investment team which managed more than USD 5bn of private equities and mezzanine investments globally. Primary responsibility was to pursue and manage mezzanine and private equity opportunities in Indonesia, to originate deals independently while also working with the bank's relationship managers to identify leads with the bank's existing clients. Julius also represented SCB on the board of investee companies.

- KC was the first independent mezzanine fund managers in Southeast Asia, investing through mezzanine and quasi-equity instruments into mid-market companies. The fund had a total AUM of USD 145m in two funds. Julius held directorship role at the General Partner entity and was responsible for the end-to-end activities of the fund management; sourcing, structuring, and execution, as well as portfolio monitoring.

At later stage, the team was spun off to become Actis, and specialised in private equities.
