The claimants claimed about TT\$11.7 Billion from the defendants in total. The claim alleged that the

Defendants procured CLICO to enter into various dubious financial schemes in return for little, valueless or at times no security and consideration. I acted as the 2nd Junior Counsel in this matter to Senior Counsel and I drafted the Defence on behalf of the Corporate Secretary and a subsequent successful application to strike out paragraphs of the Claimants' Reply.

British-American Insurance Company Limited v CL Financial Limited CV2011-02309

The Judicial Manager of the claimant insurance company brought this action against its holding company on account of its failure to honour a promissory note by two of its directors to pay the claimant the sum of US\$49,575,000.00.

I assisted Counsel in this matter by, among other things, drafting the statement of case and a summary judgment application and written submissions in support of it.

These were "claw back" proceedings by the Judicial Manager of the claimant against a former Director, Brian Branker, in respect of whether he was indebted to the claimant as a result of a loan agreement while he was a director.
