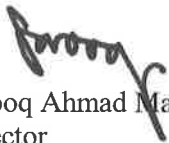

Below is an evaluation of your paper by the examiner:

The form is very good and so is the writing, analytical, insightful, and clear. The case description (background facts) is correct and accurate. The content is generally very good, although it leaves out some relevant aspects, specially concerning the Asian part of the case. The strategy is put in a persuasive and practical manner. However, it is a very risky one. It is basically all founded on the opening of administration in the UK, including for the Romanian subsidiary. This would seem, on its face, very difficult in practice, since there already is an interim procedure in place. While the general analysis of how to switch COMI is good and interesting, it fails to capture (and to quote) the more relevant and recent case law of the European Court of Justice (reg, Interedil). In any case, the student has an excellent command of complex concepts and the analysis is overall very good.

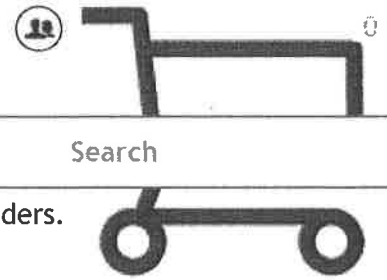

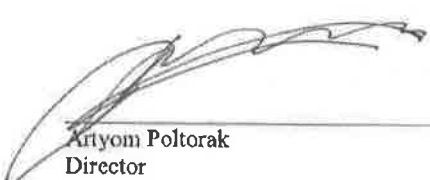

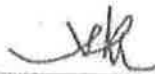
