



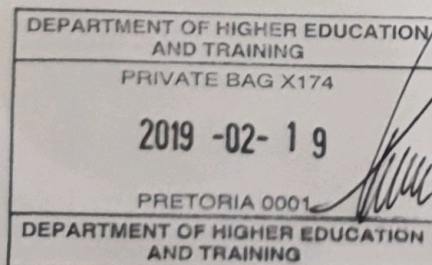
## Status of University of KwaZulu-Natal

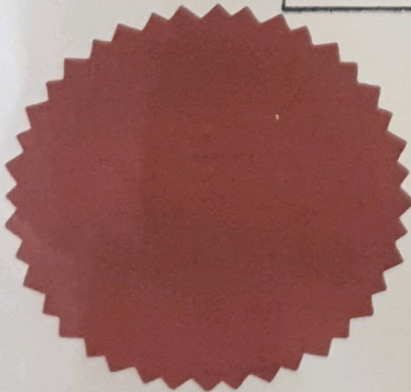
