## Why you should use an ARITA Professional Member or Fellow

ARITA Professional Members and Fellows are qualified, professional and regulated, which means you will get accurate, timely and lawful advice to help you deal with a financial crisis.

They can provide the right advice and guidance around insolvency (including bankruptcy) and business restructuring and turnaround.

**Professional Membership** of ARITA requires completion of post-Graduate level training in restructuring, insolvency and turnaround, and an extensive application process.

**ARITA Fellows** have been Professional Members for at least 10 years with an unblemished record, and have been nominated by their peers for higher recognition.

**ARITA Life Members** sit at the very top of the industry and are recognised for outstanding service to the profession. (There are only 18 ARITA Life Members.)

**Associate Membership** of ARITA is for those who work in supporting roles to the profession. Associate members choose to join ARITA to demonstrate their commitment to the restructuring, insolvency and turnaround profession and their desire to be highly engaged with the industry in which they do business. Associate membership is open to those working in, or supplying, the restructuring, insolvency and turnaround sectors such as valuers, credit managers, litigation funders etc.

Most ARITA members provide an initial meeting to discuss your circumstances, free of charge.

To be eligible for the Professional Member category you need to have at least three of the past five years working in the industry and to be a member in good standing of one of our Foundation Bodies or Law Society for the Foundation Pathway or have at least ten years' experience in the industry for the Experience Pathway. As an ARITA member in any category, you will receive:

- Quarterly issues of the ARITA Journal, the current Member Handbook (issued annually) and complimentary e-book version of the handbook.
- Member-only rates to all ARITA forums, events and education courses, helping you to stay at the forefront of your sector and achieve your required level of continuing professional development
- Access to the key member-only *in-practice* pages of the ARITA website containing the latest practice alerts, case commentaries and ARITA developed practice tools and templates.
- Additional member benefits for Professional Members are the ability to use the ARITA Post Nominals and Voting rights.

You should note that under current guidelines, if you apply to become a Professional Member more than five years after completing the ARITA Advanced Certification, your application may not be accepted and you may be required to undertake further courses to demonstrate the currency of your specialist industry knowledge and skills if your application is approved.
