You must select the Submit CFE Exam button after completing each exam section. If you fail to submit after each section, you will lose your progress and have to retake exam sections.

Your results will be emailed to you within 3-5 business days of completing all sections of the exam.

Please note the following:

- You have **30 days** from receiving your exam key(s) to take all of your exam sections. You must take each exam section within **24 hours** of unlocking it, and each exam section must be completed in one sitting.
- If you do not complete an exam section within the specified time frames, it will count as a failed attempt and be subject to retake fees.

You have **three attempts** to pass each section of the CFE Exam.

- To pass, you must accurately answer at least **75%** of the questions in each section. Any unanswered questions will be counted incorrect. If you do not pass a section within three attempts, you will forfeit any previously passed section(s). Excessive attempts to pass the CFE Exam might terminate your eligibility to continue with the CFE program.
