

CURRICULUM VITAE – PROFESSOR LYNNE TAYLOR

Lynne is an experienced, New Zealand law academic. Corporate insolvency law has been her research interest for the past 20 years. She is the lead author of *Insolvency Law in New Zealand* and a co-editor of *Corporate Law in New Zealand*, with the co-editorship role involving the coordination of a national team of authors. Both treatises are cited frequently and favourably by the New Zealand courts (see, for example, *Madsen-Ries v Cooper* [2020] NZSC 100).

Although the treatises described in the previous paragraph are primarily doctrinal works, Lynne is also an experienced empirical researcher. Since 2014 she has co-led a longitudinal study of the New Zealand law student experience funded by Ako Aotearoa (the National Centre for Excellence in Tertiary Teaching). This successful project analyses data collected from survey and focus group participants.

Much of Lynne's other research work has an empirical edge. For example, she has recently published an empirical review of the role of creditors in New Zealand's corporate insolvency regime in the Australian Journal of Corporate Law, which draws in part on primary data available from the registers maintained by the Registrar of Companies, and Insolvency and Trustee Service.

Lynne's research work frequently involves leading and/or working with teams with other academics. She is the Deputy Head of the School of Law at the University of Canterbury.

Lynne has subject expertise in relation to litigation funding in an insolvency context, having published in this area.
