EXECUTIVE POWER

PUBLIC EDUCATION DEPARTMENT

Executive Order Recognizing and Granting to Escuela Libre de Derecho the Privileges referred to by the Law Regulating Free Schools.

At the margin a seal that reads: Federal Executive Branch – United Mexican States – Mexico – Department of the Interior.

The President *Pro Tempore* of the United Mexican States has notified to the undersigned the following Executive Order:

"EMILIO PORTES-GIL," President *Pro Tempore* of the United Mexican States:

Pursuant to Articles 3 and 4 of the Law Regulating Free Schools, dated October 22, 1929 and based on the report submitted by the Secretary of Public Education, hereby recognizes and grants to Escuela Libre de Derecho the privileges mentioned by such law, according to the following sections:

FIRST. It is recognized that the studies completed at Escuela Libre de Derecho, since the date of its foundation, will have the same validity as those studies undertaken in official schools.

SECOND. The Public Education Department shall validate the official transcripts of completed studies and bachelor's degree certificates heretofore issued by Escuela Libre de Derecho. For said purpose, any interested party shall file an application with Public Education Department, attaching the bachelor's degree or official transcript issued, together with a report of Escuela Libre de Derecho, after evidencing that the student has met the requirements established by the institution to obtain the relevant official transcript or bachelor's degree certificate.

THIRD. The Public Education Department shall, after satisfying the same requirements referred to in the preceding section, validate any bachelor's degree certificate hereinafter issued by Escuela Libre de Derecho, as well as the studies undertaken in such school.

FOURTH. Escuela Libre de Derecho shall continue being a free self-governing and self-regulating institution, as it may deem advisable, and to develop its syllabus, and teaching and methodology programs; however, whenever the school changes its current status, it shall notify the Public Education Department of such change.

FIFTH. Escuela Libre de Derecho shall require that any student intending to enroll, have studied, as a minimum, the subjects mentioned hereinbelow at any official or officially-incorporated senior high school, or any other school within or outside the country whose Faculty Members certify to be a good teaching institution:

Arithmetic, Algebra and Plain and Solid Geometry. – Zoology and Botany. – Physics. – Chemistry. – Cosmography and Geography. – Logics. – Psychology, Ethics. – History National and General History, and to be fully skilled to translate from French by practical tests.

SIXTH. The minimum professional studies to be completed at Escuela Libre de Derecho and required for the validation of a bachelor's degree to be issued by the school, shall include the following subjects:

Sociology. – Economics. – Roman Law. – Civil Law. – Criminal Law. – Civil Procedure. – Criminal Procedure. – Business Law. – Administrative Law. – Public International Law. – Political Science. Constitutional Law. – Private International Law. – History of Law. – Social Legislation.

SEVENTH. The above-mentioned subjects shall be studied in four academic years, as a minimum.

EIGHTH. Escuela Libre de Derecho shall advise every year to the Public Education Department, any changes to its organization and internal regulations, and shall submit a report of the activities conducted during said academic year.

NINTH. Pursuant to the provisions of the October 22, 1929 Law, Escuela Libre de Derecho hereby expressly agrees to be subject to the inspection and supervision authority of the Public Education Department.

Decreto por el cual se concede a la Escuela Libre De Derecho el Reconocimiento y los Privilegios a que se refiere la Ley Reglamentaria de Escuelas Libres

Al margen un sello que dice: Poder Ejecutivo Federal.—Estados Unidos Mexicanos.—México.—Secretaría de Gobernación.

El C. Presidente Provisional de los Estados Unidos Mexicanos, se ha servido dirigirme el siguiente Decreto:

“EMILIO PORTES GIL, Presidente Provisional de los Estados Unidos Mexicanos:

De conformidad con lo dispuesto por los artículos 3o. y 4o. de la Ley Reglamentaria de las Escuelas Libres, de fecha 22 de octubre de 1929, y en vista del informe rendido por el C. Secretario de Educación Pública, concede a la Escuela Libre de Derecho el reconocimiento y los privilegios a que la mencionada ley se refiere, de conformidad con las siguientes cláusulas:

PRIMERA.—Se reconocen, con la misma validez que los estudios hechos en escuelas oficiales, los terminados en la Escuela Libre de Derecho, desde su fundación.

SEGUNDA.—La Secretaría de Educación Pública revalidará los certificados de estudios y títulos expedidos hasta la fecha por la Escuela Libre de Derecho. Para este fin los interesados deberán hacer su solicitud a la Secretaría de Educación acompañando el título o certificado expedido y un informe de la Escuela Libre de Derecho, en el que se haga constar qué el estudiante llenó los requisitos exigidos por el establecimiento para obtener el certificado o título de que se trate.

TERCERA.—La Secretaría de Educación Pública reconocerá con los mismos requisitos a que se refiere el artículo anterior, los títulos que expida la Escuela Libre de Derecho en lo futuro, así como los estudios que en ella se hagan.

CUARTA.—La Escuela Libre de Derecho seguirá siendo libre para gobernarse y regirse en la forma que le convenga y para formular su plan de estudios, programas y métodos de enseñanza; pero cuando modifique su régimen actual deberá dar aviso a la Secretaría de Educación.

QUINTA.—La Escuela Libre de Derecho exigirá en los alumnos que pretendan ingresar en el establecimiento, como mínimo, las siguientes materias de estudios preparatorios, hechos en escuela oficial u oficialmente incorporada o bien de escuela

dentro o fuera del país que el Cuerpo de Profesores declare de buena enseñanza:

Aritmética, Álgebra y Geometría Plana y en el Espacio.—Zoología y Botánica.—Física.—Química.—Cosmografía y Geografía.—Lógica.—Psicología, Ética.—Historia Patria.—Historia General.—Completa aptitud para traducir del Francés, demostrada en un reconocimiento práctico.

SEXTA.—El mínimo de estudios profesionales que se harán en la Escuela Libre de Derecho y que se exigirán para la revalidación de los títulos que expida, comprenderá las materias siguientes hechas en los cursos que la misma Escuela establezca en su programa:

Sociología.—Economía Política.—Derecho Romano.—Derecho Civil.—Derecho Penal.—Procedimientos Civiles.—Procedimientos Penales.—Derecho Mercantil.—Derecho Administrativo.—Derecho Internacional Públco.—Ciencia Política.—Derecho Constitucional.—Derecho Privado Internacional.—Historia del Derecho.—Legislación Social.

SÉPTIMA.—Las anteriores materias deberán estudiarse en un mínimo de cuatro años escolares.

OCTAVA.—La Escuela Libre de Derecho comunicará a la Secretaría de Educación Pública, anualmente, los cambios habidos en su organización y en su régimen interior, y rendirá un informe de las labores desarrolladas durante el año.

NOVENA.—La Escuela Libre de Derecho se somete expresamente, y de acuerdo con la Ley de 22 de octubre de 1929, a la inspección y vigilancia de la Secretaría de Educación Pública.
