Questions 1.1. - 1.10. are multiple-choice questions designed to assess your ability to think critically about the subject. Please read each question carefully before reading the answer options. The entered order, by its express terms, has a universal effect. Based on these facts alone, what is the <u>effect</u> of such order's terms in jurisdiction B if jurisdictions A and B do <u>not</u> have a bilateral agreement?

Question 1.10

QUESTION 2 (direct questions) [10 marks in total] 6 marks

Question 2.1 [maximum 3 marks] 1 mark

What is the key distinction between the application of the MLCBI and the European Union (EU) Regulation on insolvency proceedings? Also describe one key benefit and disadvantage of each approach.

MLCBI is recommendation and mechanism for dealing with cross border insolvency cases, whereas European Union Regulations is <u>a treaty</u> which forms part of EU's secondary law i.e. it becomes part of the domestic law of the EU Member States once adopted.

MLCBI is a guidance and is a soft law, as such easier to adopt as compared to European Union Regulation which requires the adopting country to change it laws.

Careful, an EU Regulation (secondary law) is not a Treaty (primary law). Description of one key benefit and disadvantage of each is missing.

Question 2.2 [maximum 2 marks] 2 marks

Explain what the court should primarily consider using its discretionary power to grant post-recognition relief under Article 21 of the MLCBI.

To grant post-recognition relief under Article 21 of the MLCBI in a foreign main or non-main proceeding, the courts should satisfy that the interests of creditors in the State are adequately protected. Further, in granting relief in a foreign non-main proceeding, the court should satisfy that the relief relates to assets that, under the law of the State, should be administered in the foreign non-main proceeding or concerns information required in that proceeding.

Question 2.3 [2 marks] 2 marks

Explain the protections granted to creditors in a foreign proceeding under Article 13 of the MLCBI.

Under Article 13 of the MLCBI, foreign creditors are granted the same rights as the local creditors in relation to commencement and participating in an insolvency proceeding. This does not affect the ranking of the claims in the proceedings, and the claims of foreign creditors cannot be ranked lower than local creditors of the same class only because the claim is of a foreign creditor.

Question 2.4 [maximum 3 marks] 1 mark

What is a key distinction with respect to the relief available in foreign main versus foreign non-main proceedings?

Foreign main proceedings are proceedings carried out in a place where the "centre of main interest" of a debtor is located, whereas, foreign non-main proceedings are proceedings in a place where a debtor carries our non-transitory economic activity with human means, and goods or services.

One of the key distinction is that is that foreign main proceedings qualify for automatic reliefs, whereas the foreign non-main proceedings do not. In Re: Zetta Jet Pte Ltd & Ors (Asia Aviation Holdings Pte Ltd, intervener), the Singapore High Court had to determine the question of the COMI of Singapore-incorporated Zetta Jet Pte Ltd.

Requires reference to Art. 20 and 21 MLCBI Requires mention of the type of relief (*discretionary*) for FNMP

QUESTION 3 (essay-type questions) [15 marks in total] 1 mark

Question 3.1 [maximum 4 marks] 0 mark

A debtor has its COMI in Germany and an establishment in Bermuda, and both foreign main and foreign non-main proceedings as well as the recognition proceedings in the US have been opened. In this scenario, explain where the foreign proceedings must have been filed, and the likely result.

The basis of commencing foreign proceedings is that the debtor must have either its COMI or at least an establishment in the State. If the debtor has COMI in Germany and an establishment in Bermuda, the creditor can commence foreign proceedings in either of these jurisdictions.

Requires references to definitional and procedural provisions of MLCBI eg. Art. 2, 15, 17, 6.. Requires the type of proceedings (FMP/FNMP)

Question 3.2 [maximum 3 marks] 0 mark

Joint provisional liquidators commenced a recognition proceeding in the US and immediately were sued and served with discovery in connection with their alleged tortious interference with contract rights of the US-based vendors of the foreign debtor. Explain the likely outcome.

To commence a recognition proceedings, the joint provisional liquidators need to submit at least a) certified copy of the decision commencing the foreign proceeding and appointing the foreign representative; or (b) A certificate from the foreign court affirming the existence of the foreign proceeding and of the appointment of the foreign representative; or (c) In the absence of evidence referred to in subparagraphs (a) and (b), any other evidence acceptable to the

court of the existence of the foreign proceeding and of the appointment of the foreign representative.

On the assumption that the requirements for recognition of foreign proceedings are met, the application for recognition of foreign proceedings must be heard at the earlier.

The onus of establishing the grounds for refusing recognition and enforcement of an insolvency-related judgment lie on the parties opposing the judgement. Discovery may be allowed, however, the courts are discouraged from refusing recognition of judgement. The grounds on which proceedings can be refused are that the interest of the creditors and other stakeholders are materially affected due to these proceedings.

It is likely that the proceedings will be recognised in the US.

Requires discussion based on Art.10 MLCBI

Question 3.3 [maximum 4 marks] 0 mark

A foreign representative who administers assets in a debtor-in-possession-like restructuring proceeding in the UK commences a recognition proceeding in the US, setting the recognition hearing 35 days after the petition date due to the availability of the court. There is no litigation pending or threatened against the foreign debtor, but US-governed leases and intellectual property licenses have *ipso facto* clauses (that is, bankruptcy-triggered terminations) that are not enforceable under the US Bankruptcy Code. Based on these facts, explain what steps, if any, should the foreign representative take to protect the assets and why?

The foreign representative can ask for a freezing order.

Requires discussion based upon Art.19 MLCBI and its definitions, as well as references to the provisions of Art 20 and/or 21 MLCBI as applicable.

Question 3.4 [maximum 4 marks] 1 mark

A foreign representative, who administers the assets of an insolvent debtor in an insolvency proceeding pending in Country A (where the foreign debtor has its registered office and not much more), commenced a proceeding in Country B to recognise the foreign proceeding as the foreign main proceeding in order to sell certain assets within the territorial jurisdiction of Country B, but unfortunately the insolvency court considering the petition for recognition denied the recognition of the foreign proceeding as a foreign main proceeding. Explain what may or should the foreign representative do next? What should the foreign representative have done at the outset?

The foreign representative should have asked to commence foreign non-main proceeding in Country B.

Art.16 MLCBI is the main reference for "rebuttable COMI presumption". References to Art.17, 21, 6 are also required

QUESTION 4 (fact-based application-type question) [15 marks in total] 0 mark

Assume you received a file for a new client of the firm. The file contains the facts described below. Based on these facts, analyse key filing strategy to ensure a successful restructuring - specifically, whether to apply for recognition of main or nonmain

proceeding or both (in light of COMI / establishment analysis), what papers need to be submitted, and what relief should be requested on day one of the filing.

The client is a Cayman Islands incorporated and registered entity. It is a financial service holding company for a number of direct and indirect subsidiaries that operate in the commercial automobile insurance sector in the United States. Globe Holdings was initially formed as a Canadian company in 2009, under the laws of Ontario, Canada. A year later, following certain reverse merger transactions, it filed a Certificate of Registration by Way of Continuation in the Cayman Islands to re-domesticate as a Cayman Islands company and changed its name to Globe Financial Holdings Inc. When it re-incorporated in the Cayman Islands in 2010 (from Canada), Globe Holdings provided various notices of its reincorporation, including in the public filings with the Securities and Exchange Commission (SEC). Around that time, Globe Holdings retained its Cayman Islands counsel Cedar and Woods, which has regularly represented Globe Holdings for over a decade. Globe Holdings has a bank account (opened just a few days ago) in the Cayman Islands from which it pays certain of its operating expenses. Globe Holdings often holds its board meetings virtually, and not physically in the Cayman Islands, and, having obtained support for a bond restructuring, all its regular and special board meetings have been organized by its local Cayman counsel virtually. The client also maintains its books and records in the Cayman Islands. Its public filings with the SEC as well as the prospectus provided in connection with the issuance of the Notes disclosed that Globe Holdings is a Cayman Islands company and explained the related indemnification and tax consequences resulting from Globe Holdings' place of reformation.

Globe Holdings has no business operations of its own. The business is carried out through its non-insurance company non-debtor subsidiaries that are all incorporated under the US laws and operating in the US. All employees are in the US. The headquarters are also in the US.

In April 2017, Globe Holdings offered and issued USD 25,000,000 in aggregate nominal principal amount of 6.625% senior unsecured notes due in 2023 (referenced above as the Notes) governed by New York law.

In 2019, Globe Holdings recorded on its consolidated balance sheet a significant increase in liabilities. As a result, Globe Holdings worked with external professional advisors to undertake a formal strategic evaluation of its subsidiaries' businesses. In September 2020, Globe Holdings announced that it was informed its shares would be suspended from the NASDAQ Stock Market due to delinquencies in filing its 10-K. Thereafter, on November 6, 2020, its shares were delisted from the NASDAQ stock market.

An independent third party is actively marketing the sale of the corporate headquarters located in New York including the land, building, building improvements and contents including furniture and fixtures.

Despite these efforts to ease the financial stress, the culmination of incremental challenges consequently resulted in Globe Holdings being both cash flow and balance sheet insolvent.

Globe Holdings retained Cedar and Woods, its long-standing Cayman Islands counsel, to advise on restructuring alternatives. Upon consultations with Cayman counsel and its other professionals, Globe Holdings ultimately determined that the most value accretive path for the Noteholders was to commence a scheme under Cayman Islands law, followed by a chapter 15 recognition proceeding in the United States, most notably to extend the maturity of the Notes and obtain the flexibility to pay the quarterly interest "in kind".

Globe Holdings expeditiously secured the support of the majority of the Noteholders of its decision to delay interest payments and restructure the Notes through a formal proceeding. Thereafter, on August 31, 2021, about 57% of the Noteholders acceded to the Restructuring Support Agreement (RSA) governed by the New York law. The RSA memorialized the agreed-upon terms of the Note Restructuring. When Globe Holdings approached its largest Noteholders regarding the contemplated restructuring, their expectations were that any such restructuring would take place in the Cayman Islands, which is reflected in the RSA.

On July 4, 2023, the client, in accordance with the terms of the RSA, applied to the Cayman Court for permission to convene a single scheme meeting on the basis that the Noteholders, as the only Scheme Creditors, should constitute a single class of creditors for the purpose of voting on the Scheme.

On July 26, 2023 the Cayman Court entered a convening order (the Convening Order) on the papers, among other things, authorizing the client to convene a single Scheme Meeting for the purpose of considering and, through a majority vote, approving, with or without modification, the Scheme. The Scheme Meeting was held in the Cayman Islands at the offices of Cedar and Woods. Given the Covid-19 pandemic, Scheme Creditors were also afforded the convenience of observing the Scheme Meeting via Zoom and in person via a satellite location in New York. Following the Scheme Meeting, the chairman of the Scheme Meeting (presiding over the meeting in person) reported to the Cayman Court that the Scheme was overwhelmingly supported by the Noteholders, with 91.83% in number and 99.34% in value voting in favor of the Scheme. The Sanction Hearing was held, and an order sanctioning the Scheme (the Sanction Order), which was filed with the Cayman Islands Registrar of Companies the same day.

During all of this time, a class action litigation was in the US was brewing but has been filed yet.

Foreign main proceedings can be commenced in the US as it can be established that Globe Holding's ("**Company**") centre of main interest is in the US. Since the subsidiaries of Globe Holdings, as well as its employees are in the US and are governed by New York Law, it can be the basis that the main interest of the Company is in US.

On day 1 of the filing in US, our client should ask recognition of the foreign proceedings in Cayman Island as well as for a stay of the restructuring proposal.

As this question is a **fact-based application-type question**, it requires the MLCBI provisions to be applied to the facts of the case and substantiated with references and a discussion. The answer should contain as a minimum: contain definitions (COMI, establishment, foreign main/non-mail proceedings etc.) with respective references to MLCBI provisions and/or other sources; a discussion on the rebuttable presumption of the COMI per Article 16(3) MLCBI and alternative courses of action; the necessary papers to be submitted to the US Court per Article 15 MLCBI; conclusive remarks with reference to Articles 19 through 22 MLCBI and 6 MLCBI...
