[A priming lien is a lien that has priority over existing liens. To be granted, the lien must provide adequate protection to the existing secured creditors and must be in the best interest of the estate]

A class of creditors must accept a plan by a majority in number and two-thirds in amount of the claims in the class]

[A bankruptcy court may enter a final order consistent with the US Constitution when it has jurisdiction over the matter and the order does not violate constitutional rights. Appeals from bankruptcy court orders are reviewed by the district court. Orders that are not constitutionally final are reviewed by the district court as well]

What provisions of the Bankruptcy Code may not be invoked by a foreign representative in a chapter 15 proceeding? What are two ways that the foreign representative can obtain equivalent relief?

# Question 4.3 [5 marks]

Speculation Inc is engaged in day-trading stocks from leased office space with two employees. It funds its trading through a margin loan from its broker, where the shares it purchases are held as collateral. For a while, Speculation Inc was very successful in trading, and the US Department of Justice (DOJ) has announced an investigation into whether its success was due to illegally trading on insider information. More recently, Speculation Inc has had serious trading losses, causing its broker to declare a default on the margin loan. It also has fallen behind on its rent, and has been sued in civil suit by a former employee alleging she was fired due to due to gender bias.

What would be the effect of a chapter 11 petition being filed by Speculation Inc on each of (i) the DOJ investigation, (ii) margin loan default; (iii) the delinquent lease and (iv) the employment discrimination lawsuit?

The filing of a chapter 11 petition by Speculation Inc would trigger an automatic stay, which would temporarily halt the DOJ investigation, the margin loan default, the delinquent lease, and the employment discrimination lawsuit. The bankruptcy court would have jurisdiction over these matters and would determine how they are to be addressed within the bankruptcy proceedings Type answer here]

Skin Luxe operates a boutique in London so it has an establishment in the jurisdiction of the scheme proceeding. Therefore recognition as foreign non-main is appropriate.
